The Clover School District Board of Trustees met on Monday, April 24, 2023, at 5:00 p.m. for executive session and for the regular business session at 6:00 p.m. Board members in attendance were Chairperson Rob Wallace, Vice Chairperson Ginger Marr, Secretary Jessica Cody, members Mike Ballard, Matt Burris, Keron Meeks, and Tracy Stiff.

# 2024-2025 SCHOOL CALENDAR - Mr. Bryan Dillon, Public Information Officer

Mr. Dillon presented the 2024-2025 <u>DRAFT school calendars</u> for First Reading. DRAFT A has a start date of August 1, 2023, and end date of May 29, 2024. DRAFT B has start date of August 5, 2023, and end date of May 29, 2024. Both calendars have the fall and winter intercession weeks. Spring break will correlate with the other York County school districts. The district leadership team and teacher forum has provided feedback on the drafts. The results of the feedback from the survey showed that 61% of the staff is in favor of DRAFT A; 39% is in favor of DRAFT B.

## POLICY UPDATES-DR. TONY HEMINGWAY, CHIEF HUMAN RESOURCES AND STRATEGIC PLANNING OFFICER

Dr. Hemingway will present a model SCSBA policy for Unencumbered Time for **Second Reading.** This is a statewide policy that each local school board can use to develop and implement a plan that directs the principal of each elementary school to provide at least thirty minutes of unencumbered time on each regular school day to all full-time teachers teaching in grades kindergarten through fifth grade, as required by Section 59-5-63, Code of Laws of South Carolina, 1976. **The policy was approved unanimously by the board for Second Reading.** 

#### FACILITIES REPORT - DR. MARK HOPKINS, CHIEF OPERATIONS AND STUDENT SERVICES OFFICER

Dr. Hopkins presented the monthly <u>facilities report</u>. Updates were provided on the bond projects, 8% projects, ESSER projects and the capital funds project. Dr. Hopkins requested approval to proceed with the shed project behind maintenance that was approved earlier by the board. The project amount is not to exceed \$100,000.00. Without objection, the board unanimously approved proceeding with the shed construction behind maintenance not to exceed \$100,000.00.

## FINANCE REPORT - MR. KEN LOVE, CHIEF FINANCE OFFICER

Mr. Love reported that the district is where we should be during this time of the year. The budget report for the month ending March 31, 2023, was shared. Bids have been received for the repair/replacement of part of the high school roof (8% funds). Mr. Love recommended awarding the contract to AAR of NC in the amount of \$1,044,265.00. Without objection, the board unanimously approved the recommendation to award the roof contract to AAR of NC in the amount of \$1,044,265.00.
